## Highly active cough remedy Antitussive & Expectorant

### Properties

**Sina Wet** represents an efficacious combination of the active principles of selected medicinal herbs for the catarrh of the upper respiratory tract, cough associated with common cold and flu, bronchitis and the obstruction of the bronchi with mucus, paroxysmal cough, allergies and bronchial asthma.

### Composition

120 ml of solution contains:

#### Medicinal Active Ingredients:

0.168 ml Quebracho bark tincture (1:5), 0.24 ml Grindelia herb tincture (1:5), 0.048 ml Pimpinella root tincture (1:5) from Pimpinella peregrina, 0.12 ml Primula root tincture (1:5) and 0.24 ml Tincture of Thyme (1:5).

#### Other Ingredients:

Special sugar syrup, eucalyptus oil, menthol, sodium benzoate and purified water.

### Mode of Action

**Sina Wet** contains active substances which diminish inflammation, facilitate expectoration, decrease irritability and relieve spasms and respiratory distress. It has an antimicrobial, and a disinfectant effects and a sputum-loosening action.

**Sina Wet** contains Cortex Quebracho which is an efficacious herb in cough; has an expectorant effect with a respiratory stimulating action and reduces the severity and frequency of asthmatic attacks.

**Sina Wet** contains Grindelia which has an anti-microbial, fungistatic, spasmolytic and inflammation-inhibiting effects.

**Sina Wet** contains Pimpinella root which has an expectorant effect specific for common cold, flu, bronchitis, fever and the inflammation of the pharynx.

**Sina Wet** contains Primula root which helps in liquefying mucus through its Saponin content which facilitates expectoration through vagal stimulation.

**Sina Wet** contains Thyme which is a bronchial antispasmodic, expectorant and anti-microbial agent. It has a spasmolytic and an expectorant effects on ciliary activity due to its Terpene content. Eucalyptus and Menthol have a cough relieving and surfactant effects, permitting easy breathing and improving pulmonary compliance.

### Indications

- Paroxysmal Cough.
- Inflammation of the bronchi and their obstruction with mucus.
- Cough associated with Common cold and Flu.
- Respiratory tract infections: Sinusitis, Tonsillitis, Naso-pharyngitis, Laryngitis, Tracheitis, Bronchitis and Pneumonia due to viral or bacterial infections.

### Contraindications

None known.

### Side effects

In rare cases, irritation of gastric mucosa.

### Dosage instructions and mode of use

Unless prescribed by the physician:



Adult dose: 1 tablespoonful 3 times daily.

Children: ½ - 1 teaspoonful 2-3 times daily according to age.

Bottle of 120 ml

Keep in a cool dry place. Close the bottle straight after use. Keep out of reach of children.
